 - a. Epoxy Lining:
 - i. Basis of Measurement: By vertical foot (VF)
 - ii. Basis of Payment: Includes interior cleaning, surface preparation, investigation to determine leaks, cementitious lining, epoxy lining, testing, work required to seal manhole/structure, flow control/bypass pumping as specified in section 33 32 40 Bypass Pumping, removal of steps, root removal, site restoration and other incidental works, testing, and traffic control.

Clarifications

Item 4. Question: Can the Notice to Proceed be pushed back to after New Year and/or after hunting season?

Answer: Notice to Proceed start date is negotiable after award provided no changes to Contract Prices and Contractor can demonstrate the work can be completed prior to SCIIP completion milestone (June 2026).

Item 5. Question: Would you consider specifying the use of VeriCure for temperature monitoring of the CIPP cure as part of the QA/QC process?

Answer: Reference Section 33 05 23.22 Section 3.5.G for temperature curing monitoring requirements. It is anticipated water level to be above pipe and potential for heat sinks during the cure. For nominal 15" pipe or greater, liner temperature monitoring along alignment of pipe is required.

Item 6. Question: Would you consider United Felts an approved CIPP Liner manufacturer per Section 33 05 23.22 Part 2.1-A?

Answer: United Felts (Martinsville, Virgina) and Applied Felts, (Martinsville, Virginia) are considered "or equal" CIPP liner suppliers. Contractor and/or Supplier responsible resin meets specification.

Item 7. Question: Is there an approved budget or engineer's estimate for the following project?

Answer: Approximate opinion of cost for the Base Bid is provided on SCBO. No additional cost estimation information to be provided.

C. Project Description: This project's intent is to repair existing collection system and mitigate inflow and infiltration. The contract is divided into three (3) general areas organized as Project 1c & 4, Project 8, and Project 9 in Oconee County. Projects 1c & 4 and Project 8 are considered the Base Bid with Project 9 and potentially other miscellaneous items being considered additive alternatives bid items. Trenchless technologies (manhole rehabilitation, CIPP) with select point repairs being used to repair and seal the system. Work to be completed within existing OJRSA maintained easements and SCDOT R/W.

D. Highlighted Key Items

- 1. This project is funded by American Rescue Plan Act (ARPA) via South Carolina Infrastructure Investment Program (SCIIP). Contractor must be compliant with SCIIP requirements. This project is subject to Davis-Bacon. Contractor and subcontractors must be registered and current with federal System of Award Management (SAM).
- 2. SCDOT Encroachment has been acquired to complete Utility work. Contractors shall be responsible for access from SCDOT road to easement through out project duration. Contractor shall be responsible to comply with conditions of the SCDOT Permit including, but not limited to, providing appropriate traffic control and daily clean up. Contractor solely responsible for ensuring public safety and a safe work site.

- 3. Contractor can utilize existing OJRSA driveways as long as drive is restored to original or better condition.
- 4. Contractor can use area in the OJRSA's Coneross WRF for stage and storage. Contractor shall be responsible for maintaining area, not obstruct access or function of OJRSA staff, vehicles, or deliveries. Contractor will return any used area to equal or better condition prior to construction. Contractor will need to coordinate directly with OJRSA on any other specifics.
- 5. CIPP liners to be cured using Hot Water. Contractor can coordinate with City of Westminster Utilities to purchase water. Contractor may use surface water filtered for solids and silt as long as compliant with South Carolina Regulation 61-119. Water is considered inclusive of the CIPP unit price.
- 6. Bypass pumping is considered incidental and inclusive in repair price except when average daily flow exceeds 2 MGD. Contractor to have bypass system monitored for the entirety it is active. Remote monitoring with call-out can be used to monitor.
- 7. Estimated daily flows and Peak Hourly flows through projects are:
 - (a) Project 1c & 5 (30 in) = 768,837 GPD (ADF); 2,700,215 GPD (Peak)
 - (b) Project 1c & 5 (Less Than 30") = 214,700GPD; 1,023,540 GPD (Peak)
 - (c) Project 8 = 131,692 GPD (ADF); 407,209 GPD (Peak)
 - (d) Project 9 = 84,672 GPD (ADF); 711,335 GPD (Peak)

- 8. Contract time is 270 days from Notice to Proceed.
- 9. For weather delays Contractor may negotiate for additional days per Contract documents. Contractor is not entitled to adjustment for Contract Price due to weather delays.
- 10. Contractor should be aware deer hunting season goes from August to January and OJRSA staff have observed multiple deer stands near the easements.

ARTICLE 7—BIDDER'S REPRESENTATIONS AND CERTIFICATIONS

7.01 Bidder's Representations

- A. In submitting this Bid, Bidder represents the following:
 - 1. Bidder has examined and carefully studied the Bidding Documents, including Addenda.
 - 2. Bidder has visited the Site, conducted a thorough visual examination of the Site and adjacent areas, and become familiar with the general, local, and Site conditions that may affect cost, progress, and performance of the Work.
 - 3. Bidder is familiar with all Laws and Regulations that may affect cost, progress, and performance of the Work.
 - 4. Bidder has carefully studied the reports of explorations and tests of subsurface conditions at or adjacent to the Site and the drawings of physical conditions relating to existing surface or subsurface structures at the Site that have been identified in the Supplementary Conditions, with respect to the Technical Data in such reports and drawings.
 - 5. Bidder has carefully studied the reports and drawings relating to Hazardous Environmental Conditions, if any, at or adjacent to the Site that have been identified in the Supplementary Conditions, with respect to Technical Data in such reports and drawings.
 - 6. Bidder has considered the information known to Bidder itself; information commonly known to contractors doing business in the locality of the Site; information and observations obtained from visits to the Site; the Bidding Documents; and the Technical Data identified in the Supplementary Conditions or by definition, with respect to the effect of such information, observations, and Technical Data on (a) the cost, progress, and performance of the Work; (b) the means, methods, techniques, sequences, and procedures of construction to be employed by Bidder, if selected as Contractor; and (c) Bidder's (Contractor's) safety precautions and programs.
 - 7. Based on the information and observations referred to in the preceding paragraph, Bidder agrees that no further examinations, investigations, explorations, tests, studies, or data are necessary for the performance of the Work at the Contract Price, within the Contract Times, and in accordance with the other terms and conditions of the Contract.
 - 8. Bidder is aware of the general nature of work to be performed by Owner and others at the Site that relates to the Work as indicated in the Bidding Documents.
 - 9. Bidder has given Engineer written notice of all conflicts, errors, ambiguities, or discrepancies that Bidder has discovered in the Bidding Documents, and of discrepancies between Site conditions and the Contract Documents, and the written resolution thereof by Engineer is acceptable to Contractor.

- 10. The Bidding Documents are generally sufficient to indicate and convey understanding of all terms and conditions for performance and furnishing of the Work.
- 11. The submission of this Bid constitutes an incontrovertible representation by Bidder that without exception the Bid and all prices in the Bid are premised upon performing and furnishing the Work required by the Bidding Documents.

7.02 Bidder's Certifications

A. The Bidder certifies the following:

- 1. This Bid is genuine and not made in the interest of or on behalf of any undisclosed individual or entity and is not submitted in conformity with any collusive agreement or rules of any group, association, organization, or corporation.
- 2. Bidder has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid.
- 3. Bidder has not solicited or induced any individual or entity to refrain from bidding.
- 4. Bidder has not engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the Contract. For the purposes of this Paragraph 7.02.A:
 - a. Corrupt practice means the offering, giving, receiving, or soliciting of anything of value likely to influence the action of a public official in the bidding process.
 - b. Fraudulent practice means an intentional misrepresentation of facts made (a) to influence the bidding process to the detriment of Owner, (b) to establish bid prices at artificial non-competitive levels, or (c) to deprive Owner of the benefits of free and open competition.
 - c. Collusive practice means a scheme or arrangement between two or more Bidders, with or without the knowledge of Owner, a purpose of which is to establish bid prices at artificial, non-competitive levels.
 - d. Coercive practice means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the bidding process or affect the execution of the Contract.

5. Byrd Anti-Lobbying Amendment:

a. Bidder who has submitted a bid of \$100,000.00 certifies to the tier above that it will not and has not used Federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, officer or employee of Congress, or an employee of a Member of Congress in connection with obtaining any Federal Contract, Grant or any other Award covered by 31 U.S.C. § 1352. - c. This certification is a material representation of fact relied upon by the Owner. If it is later determined that the Bidder did not comply with these requirements in addition to remedies available to the Owner, the Federal Government may pursue available remedies, including but not limited to suspension and/or debarment.
